On July 19, 2019 The Burbank-Glendale-Pasadena Airport Authority composed a letter to the Federal Aviation Administration requesting that the FAA take action in the interim to ensure historical flight patterns are used by aircraft operators at the Airport. The letter can be viewed [here](#).

Community concerns have been raised regarding proposed changes to the Van Nuys Airport (VNY) departure procedures which may impact current Hollywood Burbank Airport (BUR) departure procedures. On August 26, 2019 the Burbank-Glendale-Pasadena Airport Authority (BGPAA) delivered a letter to the Federal Aviation Administration Western Pacific Region requesting clarification.
