Staff seeks a recommendation by the Operations and Development Committee to the Commission to authorize Staff to renew an existing purchase order to Azrial, LTD, a sole proprietor firm that has provided time and material computer-aided drafting services to the airport Engineering Department for more than 20 years. This revised purchase order would continue to be on a time and materials basis at an hourly rate of \$78 per hour, not to exceed 2,000 hours annually, for a five-year period. An annual allowance of \$5,000 for miscellaneous out-of-pocket expenses such as paper, ink and reproduction costs, and a \$2 per hour amount added for the cost of Professional Liability Insurance would also be included in the purchase order.
