Staff will be issuing a Request for Proposal for insurance brokerage services for all the Authority's insurance coverages. In the interim, Staff has negotiated with Aon Risk Services, the retail brokering and risk management services arm of Aon Corporation that provides insurance brokerage services for the Authority, and seeks a Committee recommendation to the Commission authorizing Staff to extend the insurance brokerage service contract with Aon for one year, with no change in fees from last year's amount of \$90,000.

- b. First Amendment to Lease Agreement for Hertz Equipment Rental Corp.

Staff seeks a Committee recommendation to the Commission that it approve a proposed First Amendment to the January 17, 2006, Lease Agreement between Hertz Equipment Rental Corporation and the Authority to extend for five years the current lease for the 210,844 square feet of land located at 3111 North Kenwood Avenue, which is scheduled to expire on May 16, 2016. The proposed Amendment provides that the rent for this property will be increased to \$840,000 annually.
