- a. COMMITTEE MINUTES Approved minutes of the March 6, 2017, Operations and Development Committee, the Finance and Administration Committee; and the February 6, 2017, Legal, Government and Environmental Affairs Committee meetings are included in the agenda packet for information purposes.
- b. COMMISSION MINUTES March 20, 2017 The draft minutes of this meeting are attached for Commission review and approval.
- c. MONTH-TO-MONTH GROUND LEASE OVERFLOW STORAGE FOX RENT A CAR, INC. A staff report is included in the agenda packet. At the March 20, 2017, Finance and Administration Committee meeting, the Committee voted (2-0, one absent) to recommend to the Commission approval of a Month-to-Month Ground Lease between Fox Rent a Car, Inc. ("Fox"), and the Burbank-Glendale-Pasadena Airport Authority for overflow storage of Fox's rent-a-car inventory. The lease is for 30,998 square feet of the former rent-a-car service area located off of Empire Avenue in the southwest quadrant of the airport. Under the proposed Lease, rent will be \$5,579.64 monthly.
- d. ANNUAL REVIEW AND ADJUSTMENTS OF NOISE VIOLATION FINES A staff report is included in the agenda packet. At the March 20, 2017, Legal, Government and Environmental Affairs Committee meeting, the Committee voted (2-0, one absent) to recommend to the Commission that it authorize Staff to increase the noise fines associated with certain restricted operations as detailed in Rules 8 and 9 in accordance with the annual adjustment of noise violation fines required by Resolution No. 382.
