Avis Rent a Car System, LLC, executed a Non-Exclusive On-Airport Rental Car Lease and Concession Agreement with the Airport Authority for space in the RITC in April 2012. Due to ownership changes, Ameriflight, LLC desires to assign its Master Tenant Lease to Pebbles Aviation, LLC. This assignment will not impact services and operations provided by Ameriflight at the Bob Hope Airport.
