1. Approval of Agenda There were no adjustments to the agenda.

2. Public Comment There were no public speakers.

3. Approval of Minutes

a. March 20, 2017 Commissioner Quintero abstained from commenting

on the minutes as he did not attend the March 20, 2017, meeting. Commissioner Madison moved approval of the minutes and, there being no objection,

the minutes were approved (2-0, one abstention).

b. May 15, 2017

Commissioner Madison abstained from commenting on the minutes as he did not attend the May 15, 2017, meeting. Commissioner Quintero moved approval of the minutes and, there being no objection, the minutes were approved (2-0; one abstention).

4. Contracts and Leases

a. Award of Professional Services
 Agreement to Arnold & Associates
 for Legislative Representation
 Services Contract.

Arnold & Associates ("Arnold") has provided legislation representation services in Sacramento for the Airport Authority since 2002. The two principals at Arnold are Michael Arnold and Kristian Foy, who bring 65 years of combined experience to their practice of representing local governments in Sacramento.

Staff reported that Arnold's most recent agreement expires on June 30, 2017. Staff has negotiated with Arnold a proposed new professional services agreement covering current services for a three-year term at the existing compensation rate (\$8,000 per month flat fee plus expenses) for the duration of the new contract with a fifteen day termination. The new agreement would be effective July 1, 2017, and would run through June 30, 2020.

Arnold routinely helps identify proposed bills of interest to the Authority at the start of the legislative year and tracks proposed legislation throughout the process and periodically briefs the Legal, Government and Environmental Affairs Committee. Arnold actively assist Staff in its communications with members of state government.

Staff recommended that the Committee recommend to the Commission that it approve a new three-year professional services agreement, effective July 1, 2017, with Michael J. Arnold & Associates to render legislative representation services at the rate of \$8,000 per month plus expenses.

Following the presentation the Committee agreed unanimously (3-0) to approve Staff's recommendation.

There being no further business, the meeting was adjourned at 10:14 a.m.
