## COMMISSION NEWSLETTER August 3, 2015

### [Regarding agenda items]

#### 5. ITEMS FOR COMMISSION APPROVAL

- a. PROJECT NUMBER E12-18, RUNWAY 8-26 AND RUNWAY 15-33 SHOULDER REHABILITATION, INCREASE OF APPROVED CONTINGENCY A staff report is included in the agenda packet. At the July 13, 2015, meeting of the Operations and Development Committee, the Committee voted 2–0 (one Committee member vacancy) to recommend to the Commission that it increase the approved contingency for the Runway 8-26 and Runway 15-33 Shoulder Rehabilitation Project to fund the cost of drainage swale pavement. The funding for this additional paving would be provided through the use of underruns in grant utilization for the recently-acquired Aircraft Rescue and Fire Fighting ("ARFF") vehicle and the anticipated underrun on the quantity of in-scope pavement work required under the original contract. Staff seeks authorization to have the contractor for the shoulder project perform additional work, after the initial scope work has been completed, in an amount not to exceed \$500,000 to repave the drainage swales.
- b. 9/80 ALTERNATIVE WORK SCHEDULE A staff report is included in the agenda packet. At its July 13, 2015, meeting the Operations and Development Committee voted 2–0 (one Committee member vacancy) to recommend to the Airport Authority approval of a 9/80 Alternative Work Schedule pilot program. A 9/80 schedule is a type of alternate work schedule that allows full-time employees to work longer days for part of a set period in exchange for a day off each period. This pilot program would not be offered to Fire, Police and Maintenance Department union employees, who are subject to collective bargaining agreements, and to employees of Airside Operations, who currently are on a 4/10 schedule, another type of alternate work schedule.
- c. TERMINAL SPACE LEASE, NEWZOOM, INC. A staff report is included in the agenda packet. At its July 13, 2015, meeting the Finance and Administration Committee voted unanimously (3–0) to recommend to the Commission that it enter into a terminal space lease with NewZoom, Inc., dba ZoomSystems, to provide a post-security concession kiosk and authorize the Authority President to execute same. ZoomSystems will provide an unmanned retail store kiosk, Amazon ZoomShop, to be located adjacent to Gate A2, to dispense consumer electronic products, primarily Amazon Kindles and associated accessories. Prices for the products in the kiosk are the same as those on Amazon's website. Staff has been able to negotiate rent at the greater of \$250 per month or 9% of gross sales, which is on the higher end of what other airports are receiving for rent for this same concession.

### 6. ITEMS FOR COMMISSION DISCUSSION

a. SUMMER CAMP AIRPORT TOUR – No staff report is attached. On July 9, 2015, the Airport Authority sponsored its ninth Airport tour for Robert Gross Park Summer Camp. Staff will provide a presentation on this outreach event.

### 7. ITEMS FOR COMMISSION INFORMATION

- a. AIRLINE SCHEDULE ANALYSIS A staff report is included in the agenda packet. Included in the agenda packet for noting and filing are schedule analyses reflecting summer seasonal changes in service and fleet mix and scheduled operating times for three airlines serving Bob Hope Airport. After incorporating these changes the noise impact area is projected to have a cumulative decrease of 0.52 acres.
- b. JUNE 2015 PASSENGER/CARGO STATISTICS AND PARKING INFORMATION No staff report is attached. The June passenger count of 336,978 was up 2.8% from last year's 327,858, and the total for the first half of the year is up 2.2% at 1,930,712 compared to 1,889,436 in the first half of 2014. Total airline seats in June declined 0.5%, from 458,300 in 2014 to 456,146 in 2015. Air Cargo volume declined 3.6% to nine million pounds in June 2015, and the year-to-date tally of 53.1 million pounds is down 0.7%. Airline aircraft operations dropped 2.2% the first half of the year. A complete report is included in the agenda packet.
