Following completion of a comprehensive competitive selection process, Staff seeks a Committee recommendation to the Commission that it enter into a Fleet Maintenance Services Agreement with Keolis Transit Services LLC for a three-year period, with two one-year extension options, and authorize the Authority President to execute the Agreement. This agreement is for time and materials services, with an expected first year total cost of approximately \$265,000, based on an average annual price of \$140,000 for labor and \$125,000 for parts (including a 25% markup on parts ordered through Keolis.) Services will be billed monthly.
