The Authority's independent auditor, Macias Gini & O'Connell LLP has completed its audits of the Airport Authority fiscal year 2014 financial statements. A copy of the audited Basic Financial Statements for the fiscal years ended June 30, 2015 (FY 2015) and 2014 (FY 2014) was previously distributed to the Committee. Also previously distributed to the Committee were copies of the audited Single Audit Reports (audit of federal grant programs), Passenger Facility Charge Audit Reports, Customer Facility Charge Audit Reports, Independent Auditor's Report on Compliance with Section 6.05 of the Bond Indenture, and the Auditor's Report to the Authority Regarding the FY 2015 Audits.

Staff will present each report and provide an overview and analysis of financial results for the fiscal year ended June 30, 2015. MGO will present a summary of its audits. Staff seeks a Committee recommendation to the Commission that it note and file these audit reports.

Formerly mandated by State law and now currently recommended under Sections 53646(a)(2) and 53646(h) of the California Government Code, the Commission annually reviews and approves an investment policy to identify policies and procedures for the prudent and systematic investment to be followed by the Authority Treasurer in the exercise of the investment authority delegated to him/her.

The Authority's Investment Manager, Columbia Management Investment Advisors LLC, has opined that the 2015 Authority Investment Policy, with overall investment criteria of capital preservation (safety) and liquidity, is solid and conservative and it does not need revisions at this time. Staff concurs with the CMIA findings and seeks a Committee recommendation to the Commission that it adopt the attached proposed Resolution approving the 2016 Investment Policy (Attachment 1), which reaffirms the current 2015 Investment Policy with no changes.
