4. CONSENT CALENDAR

- c. CONSENT TO SUBLEASE AMENDMENT TO THE DEVELOPMENT GROUND LEASE BETWEEN THE BURBANK-GLENDALE-PASADENA AIRPORT AUTHORITY AND MERCURY AIR CENTER-BURBANK, INC. dba ATLANTIC AVIATION-BUR A staff report is included in the agenda packet. Mercury Air Center-Burbank dba Atlantic Aviation-BUR and Avjet Corporation have amended an existing agreement between them that allows Avjet to sublease from Atlantic Aviation the premises commonly known as Hangars 6, 7, 7A and 7B. The amendment to that agreement was effective October 28, 2013, and extended the sublease term to 2025.

The existing Development Ground Lease between the Airport Authority and Atlantic Aviation requires that any such amendment to a subleasing arrangement requires the consent of the Authority. Accordingly, Staff has prepared a proposed Consent to Sublease Amendment to the Development Ground Lease. At the December 16, 2013, meeting of the Finance and Administration Committee, the Committee voted 2–0 (1 absent) to recommend to the Authority that it approve the Consent to Sublease Amendment between the Authority and Atlantic Aviation. Due to the voluminous nature of the Development Ground Lease, a copy of the lease is not included in the agenda packet. However, a copy of the lease will be available at the meeting for the Commissioners' review if so desired.

d. TREASURER'S REPORTS – The June 2013 Treasurer's Report is included in the agenda packet. The report was presented to the Finance and Administration Committee at its December 16, 2013, meeting at which time the Committee recommended 2–0 (1 absent) that it be noted and filed by the Commission.

5. ITEMS FOR COMMISSION APPROVAL

a. OTHER TRANSACTION AGREEMENT AMENDMENT III AND CHANGE ORDER FOR THE BAGGAGE HANDLING SYSTEM UPGRADE TO PDGS V4.1 – A staff report is included in the agenda packet. This item has been included in the Authority's agenda subject to the review and recommendation of the Operations and Development Committee at its January 21, 2014, meeting immediately prior to the Authority meeting.

As part of a U.S. Department of Homeland Security – Transportation Security Administration ("TSA") funded multi-phased project to enhance the baggage inspection system at Burbank Bob Hope Airport, Staff seeks Authority authorization for Staff to execute a TSA-directed amendment to the Other Transaction Agreement between the Authority and the TSA and execute a change order to Authority Purchase Order A5333 with G&S Airport Conveyor in the amount of \$112,700 as requested by the TSA. This amendment and change order would provide for additional facility modifications determined to be necessary for the project.

6. ITEMS FOR COMMISSION DISCUSSION

- a. PART 139 INSPECTION RESULTS No staff report is attached. Staff will report to the Commission the results of the FAA Part 139 Inspection held during the first week in December 2013.
- b. FY 2013 BUDGET PERFORMANCE REVIEW A staff report is included in the agenda packet. Staff monitors the actual financial performance of the Burbank-Glendale-Pasadena Airport Authority against the approved budget to determine if the financial performance is within the parameters set forth in the annual Budget Resolution. A review of the actual performance of the FY 2013 budget by account depicts the positive achievement during difficult and challenging economic conditions for both the Operations and Maintenance Budget and the Facility Improvement Program. As such, a budget amendment resolution for the FY 2013 financial results is not required.
- c. ENVIRONMENTAL IMPACT REPORT (EIR) UPDATE No staff report is attached. Staff will update the Commission on the status of the 14-gate Replacement Terminal/ Opportunity Site EIR process to date.

7. ITEMS FOR COMMISSION INFORMATION

- a. METRO GRANT AWARD FOR EMPIRE AVENUE BRIDGE No staff report is attached. Staff will brief the Commission on funding opportunities available for the construction of a bridge connecting the Regional Intermodal Transportation Center to the existing rail platform on the Ventura rail line on Empire Avenue in light of Metro's recent grant application.
- COMMUNITY EVENTS No staff report is attached. Staff will update the Commission regarding various event drives undertaken by Staff over the holiday period.

c. AIRLINE SCHEDULE ANALYSIS – Included in the agenda packet for noting and filing are schedule analyses reflecting seasonal changes in service, fleet mix and scheduled operating times for three airlines serving Bob Hope Airport which reflect the seasonal demand for the first two months of the year. After incorporating these changes, the noise impact area is projected to decrease by 0.45 acres.
