Arnold and Associates has provided legislative representation services in Sacramento for the Authority since 2002. The agreement with Arnold has been reviewed and renewed on an annual basis. The

current term for the firm's services expired June 30, 2014. Staff recommends that the Commission enter into a new professional services agreement for a three-year term, effective July 1, 2014, and running through June 30, 2017. The rate of compensation would be \$7,000 per month plus expenses for the first year and \$8,000 per month plus expenses for the remaining two years.

Staff seeks the recommendation of the Committee to the Commission that it approve a new professional services agreement for a three-year agreement with Arnold and Associates effective July 1, 2014.
