Staff seeks a Committee recommendation to the Commission that it award a construction contract in the amount of \$119,685 to E.C. Construction to complete Phase 2 of the rehabilitation of the remaining 50,000 square feet of asphalt pavement at the Hangar 2 Aircraft Parking Ramp. Staff also seeks approval of an approximate 10% aggregate contingency in the amount of \$12,000 to permit Staff to authorize any necessary changes in the scope of the project during the course of construction.

As part of the Airport Authority's continuing effort to develop stronger geographic location recognition for the Airport, as well as generate additional passengers, in December 2014 the Authority engaged Anyone Collective to provide airport branding consultant services. Over the past several months, Anyone Collective has done extensive research and due diligence in order to recommend a branding/marketing name for the Airport which will create clear and strong geographic location recognition, particularly for prospective passengers east of the Rocky Mountains who are traveling to the Los Angeles area. Based on this comprehensive research, Anyone Collective recommends that the Airport use "Los Angeles Burbank Airport" as its brand name. Staff concurs with Anyone Collective's recommendation.

While the legal name of the Airport will remain Bob Hope Airport, use of the Los Angeles Burbank Airport brand name will provide a better understanding of the Airport's proximity to popular tourist attractions in the Tri-Cities, Hollywood and Los Angeles and make it easier for potential passengers traveling to the Los Angeles area to identify the Airport as a viable option when planning their travel.

Staff seeks a Committee recommendation to the Commission to use "Los Angeles Burbank Airport" as the Airport's brand name.
