Staff seeks a recommendation of the Committee to the Commission that it approve a Second Amendment to the Ground Lease with Century West, LLC, dba Century West BMW, LLC, for the purpose of extending by two additional months the Ground Lease of approximately 33,417 square feet of the southern portion of paved surface located on Kenwood Street, south of Cohasset, in the City of Burbank, located in the northeastern quadrant of the Airport. Century West BMW has been utilizing this area since October 1, 2014, for the purpose of storing vehicles to support its operation. The proposed Second Amendment to Ground Lease will generate \$10,693.44 for the two-month term.
