#### WEDNESDAY, MARCH 7, 2012

A regular meeting of the Legal, Government and Environmental Affairs Committee was called to order this date in the Burbank Room of the Burbank-Glendale-Pasadena Airport Authority, 2627 Hollywood Way, at 8:35 a.m., Burbank, California, by Chairman Wiggins.

1. Public Comment There were no public speakers.

2. Approval of Minutes

a. February 22, 2012 Commissioner Quintero moved approval of the minutes of

the February 22, 2012, meeting. There being no objection,

the minutes were approved 2–0 (1 absent).

In the interest of time, agenda items 3.b. and 3.c. were taken out of sequence.

3. Items for Information

b. Federal Legislative Update

Cliff Madison, the Airport Authority's Washington, D. C., legislative consultant, via teleconference briefed the Committee regarding national airport-related issues and discussed H.R. 658 (FAA Modernization and Reform Act of 2012) which was signed into law on February 14, 2012. Regarding a provision in the bill affecting airports that are closed due to inclement weather, Mr. Madison will research the deadline for required contingency plans which airports must file with the FAA and report back to Staff.

Commissioner Madison noted that California
Congresswoman Judy Chu, who now represents
approximately 90% of the Pasadena area, is very familiar
with the Bob Hope Airport and could be supportive to the
Authority. The Authority's federal legislative consultant will
contact Congresswoman Chu to arrange a tour of the Airport
for her—hopefully during Congress' April 2012 break—and
get back to Authority staff with additional information
regarding scheduling.

### c. State Legislative Update

Via teleconference the Authority's Sacramento legislative consultant, Michael Arnold, updated the Committee on airport-related legislative issues he has been monitoring and answered various questions from the Committee.

Bills which Mr. Arnold will continue to closely monitor include the following: AB 817 regarding vehicle rental contracts; AB 1704, which would prohibit coal tar pavement products for use on airport runways; AB 2182 regarding airport fire arms arrests; AB 2379, which would make a technical, nonsubstantive change to the definition of an authorized driver in vehicle contracts; and AB 957, the Senate version of the budget bill. With regard to AJR 25, an Assembly Joint Resolution that would restrict helicopter noise in the Los Angeles area, Staff will consult the Authority's federal legislative consultant to ascertain if there is an existing federal act on this issue.

The meeting continued with agenda item 3.a., followed by the remaining agenda items.

#### a. Review of Community Event Support

Staff briefed the Committee on the Authority's community event support in the three members cities. It has been the Authority's practice to participate in the three city chambers of commerce and support their events, and to sponsor other community events that would enhance acceptance of the Airport, in keeping with the requirements of FAA policy regarding airport revenue usage.

As part of the ongoing austerity efforts to proactively address the current economic conditions, Staff is examining the Authority's level of participation in various community events that typically involve membership or sponsorship expenses. Staff proposes to maintain as much participation as possible in these groups or events as originally envisioned in the adopted budget, but at a reduced level of contribution.

Staff discussed with the Committee a chart indicating community event support for the first half of fiscal year 2011/2012. Of some \$43,000 budgeted this year to cover chamber participation and community events,

approximately \$22,000 has been spent to date, leaving just under \$21,000 to be considered for revisions for the remainder of the fiscal year. In this regard, Staff discussed with the Committee potential reductions that would provide savings of approximately \$8,000.

Staff will re-evaluate the community event support, keeping in mind the standard of enhancing acceptance of the Airport in the community, and present it to the budget committee as part of its development of the proposed FY 2012/2013 budget presentation to the Finance and Administration Committee prior to submittal to the Commission.

4. Other Legal,
Government and
Environmental Affairs
Matters

Staff reported that in mid-December of 2011 the FAA issued a letter to airports regarding the fostering of small businesses and the guideline that is now to be included in DBE programs. Although dated December 2011, Staff did not receive the letter until February 2012. Staff is working with the Authority's legal counsel to prepare a draft submittal to the FAA for its review and comments prior to presenting it to the Legal, Government and Environmental Affairs Committee for consideration.

Regarding regularly scheduled meetings of the Legal, Government and Environmental Affairs Committee, Staff will look into the Committee's request to meet immediately following the Commission's regularly scheduled meetings and will report back to the Committee.

5. Closed Session

The meeting did not recess to closed session.

### ANNUAL REVIEW AND ADJUSTMENT OF NOISE VIOLATION FINES

#### DESCRIPTION

Staff seeks a Committee recommendation to the Commission to authorize Staff to increase the noise fines associated with certain restricted operations and or Stage 2 aircraft as detailed in Rules 8 and 9 as described below, in accordance with the annual adjustment of noise violation fines required by Resolution No. 382.

#### BACKGROUND

Resolution No. 382 was adopted by the Airport Authority on March 20, 2003, and calls for noise violation fines contained in Rules 8 and 9 to be adjusted annually for inflation based on percentage changes in the Consumer Price Index (CPI). Historically, the January index has been used to calculate this adjustment and the new rates are effective each April 1.

Rule 8 prohibits the following activities between 10 p.m. and 7 a.m.:

- Intersection takeoffs
- "Touch and go" landings
- Maintenance run-ups
- Flight training operations
- Practice Approaches

The current first-time fine is \$1,359 and the fine for subsequent violations is \$1,976.

Rule 9 prohibits the operation of certain "noisy" aircraft between 10 p.m. and 7 a.m., pursuant to FAA Advisory Circular 36-1H. The current fine for each violation is \$3,953.

In 2011 Staff sent 32 notices to aircraft operators for suspected violations. After further investigation, all 32 of these operations were determined to be in compliance with the Airport Noise Rules. None of these notices resulted in the issuance of a noise fine.

#### JANUARY 2012 CPI INDEX LEVEL

The January 2012 CPI for All Urban Consumers in the Los Angeles, Riverside and Orange County area was 233.441 according to the U.S. Bureau of Labor Standards. This level represents an increase of 2.1% when compared to the January 2011 index reading of 228.652.

### JOINT APPLICATION FOR METROPOLITAN TRANSPORTATION AUTHORITY GRANT FUNDING FOR TRANSIT-ORIENTED DEVELOPMENT

#### SUMMARY

Staff seeks a Committee recommendation to the Commission supporting the direction Staff is pursuing in order to obtain outside funding to assist both the Airport Authority ("Authority") and the City of Burbank ("City") in studying transit-oriented development on and adjacent to the Bob Hope Airport.

#### BACKGROUND

In June 2011 the Authority commenced a Ground Access Study ("Study") that will comprehensively study a variety of public transportation improvements that could significantly reduce Airport traffic on local streets as well as reduce local non-Airport-related traffic. The Study is funded with a Federal Highway Administration ("FHWA") grant that has a 20% local match obligation.

In September 2011 contracts were awarded for the first two components of that Study to Emerson & Associates and to Unison Consulting for strategic planning and data collection and analysis, respectively. Staff and its project manager, Orangeline Development Authority ("OLDA"), are presently completing a combined Request for Qualifications & Proposals for the main body of the study, known as the Multi-Modal Ground Access Study ("MGAS").

On March 15, 2012, the City and the Authority jointly released the results of a community opinion survey that was recently conducted by an independent professional research firm. That survey, commissioned by the City and Airport staffs, is the initial step in an ongoing process of the City and the Airport working together to create a future vision for the Airport, including the future disposition and/or development of the B-6 property.

The Airport Authority and the Burbank City Council each tasked their staffs to work together to address these issues as the Airport Land Use Working Group ("ALUWG"). That group has identified a need for outside consulting services that would provide valuable information about how the development of a new Metrolink Station at Bob Hope Airport, as well as other proposed transportation improvements that may result from the ground access study, could affect traffic congestion. Further, it would be useful to identify the types and magnitude of development that could be considered for the B-6 property that would be harmonious with the long-term objectives of the City and the community, and how this development could take advantage of, and benefit from a new Metrolink Station and other forms of improved public transportation.

The City had previously sought to engage an outside planning firm to begin providing this core information. However, because of the State-mandated termination of the City's Redevelopment Agency and the funding that would have come from it to pay for this study, a different funding mechanism is now required.

On February 23, 2012, the Metropolitan Transportation Authority ("MTA") issued a supplemental round of requests for Transportation-Oriented Development ("TOD") proposals with up to \$1,000,000 in additional funding available to multiple public entities (MTA Staff Report and Program Guidelines attached). As described in greater detail below, Staff believes that this solicitation provides an opportunity to provide the ALUWG a mechanism for generating useful background data about potential transit-related land use at and in the vicinity of the Bob Hope Airport, while at the same time providing a funding opportunity that would aid the Authority in meeting its local match requirement under the primary funding source for the ongoing Ground Access Study.

#### **PROPOSAL**

Staff proposes to partner with the City of Burbank as joint applicants for a \$350,000 portion of this potential TOD funding. The scope of work currently being drafted for the MGAS will be expanded to include a subsection that incorporates the additional scope that meets the City's needs and requirements. This potential opportunity has been discussed in broad terms with the Airport Land Use Working Group and Staff has also participated in a meeting with City staff exploring this opportunity in greater detail.

Applications are due to MTA on April 6, 2012. The MTA Program Guidelines require that an application from a Joint Powers Authority or Agency must also include a Letter of Support from "all targeted local governments." The City staff confirmed that this proposed joint application and an appropriate draft letter of support have been placed on the City's agenda for its March 27, 2012, City Council meeting.

NOW, THEREFORE, THE COMMISSION FINDS, DETERMINES, AND RESOLVES AS FOLLOWS:

Finance and Administration Committee

Legal, Government and Environmental Affairs Committee

First and Third Monday of each calendar month, at 10:30 a.m. or immediately following the conclusion of any regular meeting of the Commission occurring on such day, in the Burbank Room of the Bob Hope Airport.
