The current agreement with Cooper Communications, Inc. ("Cooper") expires May 31, 2012. Marty Cooper, principal of Cooper Communications, has served as the chairman of the Airport Land Use Working Group ("ALUWG") Outreach Subcommittee in its work to implement the extension of the Development Agreement following its passage by the City of Burbank and the Airport Authority. His work with the ALUWG will continue throughout 2012 and into 2013. Staff believes Cooper's continuing service is integral to this effort. Cooper has presented a proposal for a new one-year period. The terms of the new agreement would remain unchanged from the flat \$12,000 monthly retainer currently in effect. Staff seeks a recommendation from the Committee to the Authority for award of the new contract.
