Staff seeks a recommendation from the Committee to the Commission that it approve a six-month Ground Lease with Century West, LLC, dba Century West BMW, LLC, for the purpose of leasing approximately 33,417 square feet of the southern portion of a vacant paved parking space on Kenwood Street, south of Cohasset, in the City of Burbank located in the northeastern quadrant of the Airport. Century West BMW will be utilizing this space for the purpose of storing vehicles to support its operation for a six-month period. The proposed Ground Lease, a copy of which is attached, will generate approximately \$32,080 for six months.
