### COMMISSION NEWSLETTER October 5, 2015

#### [Regarding agenda items]

#### 5. CONSENT CALENDAR

(Consent Calendar items may be enacted by one motion. There will be no separate discussion on these items unless a Commissioner so requests, in which event the item will be removed from the Consent Calendar and considered in its normal sequence on the agenda.)

a. AWARD OF LEASE AND MAINTENANCE SERVICES AGREEMENT TO COPY-R OFFICE SOLUTIONS, LLC, FOR COPIER LEASE AND MAINTENANCE SERVICES – A staff report is included in the agenda packet. This item has been included in the Authority's agenda subject to the recommendation of the Operations and Development Committee at its October 5, 2015, meeting immediately prior to the Authority's meeting.

As the copy machine fleet of the Authority has reached its end of life, Staff seeks Commission authorization to award a lease and a separate maintenance agreement to Copy-R Office Solutions, LLC for twelve (12) new multi-function copiers. The proposed lease agreement is for a five (5) year term in the monthly amount of \$1,038.31. The Fiscal Year 2015/2016 lease payments can be accommodated within the current fiscal year's copy machine account budget. The proposed four (4) year maintenance agreement of \$408.09 monthly will commence in the second year of the copy machine lease agreement and will be included in the proposed 2016/2017 Fiscal Year Budget. The total combined cost over the lease term for the 12 new multifunction copiers and the annual maintenance services agreement is approximately \$81,887.

  - a. AD HOC COMMITTEE APPOINTMENTS No staff report is included. This item has been placed on the Commission's agenda to provide the Authority President the opportunity to appoint members to an ad hoc committee. The Authority currently has two ad hoc committees.

Commission Resolution No. 311 requires that the membership of each ad hoc committee have equal representation from the three JPA cities. Additionally, this resolution generally precludes Commissioners from serving on more than one ad hoc committee.

 a. 2015 UPCOMING FALL/HOLIDAY CHARITY EVENTS – No staff report is included. An overview of upcoming charity events that Airport staff will be coordinating and participating in will be presented.

- 8. ITEMS FOR COMMISSION INFORMATION
  - a. BURBANKBUS UPDATE David Kriske from the City of Burbank will provide the Commission with an update on the first three months of passenger operations since the local BurbankBus service expanded its schedule to all-day service between the Airport and the North Hollywood Red Line Station.
  - b. AUGUST 2015 PASSENGER/CARGO STATISTICS AND PARKING INFORMATION No staff report is included. The August passenger count of 342,095 was basically flat from the prior year's count of 342,390. The total for the first eight months of the year is up 2.08% at 2,607,545 compared to 2,554,338 through August 2014. Total airline seats in August decreased by 2.22%, from 472,190 in 2014 to 461,725 in 2015. Air Cargo volume declined 7.55% to 8.7 million pounds in August 2015, and the year-to-date tally of 71.1 million pounds is down 2.25%. Airline aircraft operations were essentially flat for the first eight months of the year. A complete report is included in the agenda packet.
