5. CONSENT CALENDAR

- a. REVISED AIRPORT PROCEDURE FOR RECORDS RETENTION AND DESTRUCTION – A staff report is included in the agenda packet. At the September 8, 2015, meeting of the Legal, Government and Environmental Affairs Committee, the Committee voted 2–0 (one absent) to recommend that the Commission adopt the attached Authority Resolution No. 465 establishing a revised Airport Procedure No. 2150 for records retention and destruction.
- b. AWARD OF CONTRACT TO GAIL M. GOLDMAN, LLC, FOR AIRPORT ART CONSULTANT SERVICES A staff report is included in the agenda packet. At the September 8, 2015, meeting of the Legal, Government and Environmental Affairs Committee, the Committee agreed (2–0, one absent) to recommend to the Commission that it award a lump-sum professional services agreement in the amount of \$22,500 to Gail M. Goldman, LLC, for Airport Art Consultant Services, to coordinate the art selection, the approval process between all of the municipal stakeholders, and installation to satisfy the City of Burbank Art in Public Places requirement for the Regional Intermodal Transportation Center at the Bob Hope Airport.

6. ITEMS FOR COMMISSION APPROVAL

a. AWARD OF CONTRACT TO MV TRANSPORTATION, INC., FOR COURTESY SHUTTLE SERVICES – A staff report is included in the agenda packet. As part of the Authority's continuing effort to provide its parking customers and employees the highest level of safe and efficient parking lot transportation, Staff conducted a competitive solicitation for courtesy shuttle services at the Airport. Faced with the complications of an aging shuttle fleet, Staff pursued a turn-key solution that would seek to provide, operate and maintain a new alternative-fueled shuttle fleet dedicated to the Airport.

At the September 8, 2015, Operations and Development Committee meeting, the Committee agreed unanimously (3–0) to recommend to the Commission that it award to MV Transportation, Inc. an Agreement for Courtesy Shuttle Services with a fixed-price, five-year base term (November 1, 2015, through November 30, 2020) with two fixed-priced, one-year extension options available to the Authority.

b. PROJECT NUMBER E15-01, RUNWAY AND EMAS REHABILITATION – A staff report is included in the agenda packet. At the September 8, 2015, Operations and Development Committee meeting, the Committee voted unanimously (3–0) to

recommend to the Commission that it authorize the Executive Director to execute a professional services agreement for an engineering design contract in the amount of \$1,085,770 to RS&H California, Inc. for the Runway and Engineered Materials Arresting System Rehabilitation Project.

- c. SITA AIRPORT SOLUTION LINE SERVICE AGREEMENT A staff report is included in the agenda packet. At its September 8, 2015, meeting the Operations and Development Committee agreed unanimously (3–0) to recommend to the Commission approval of a proposed Airport Solution Line Service Agreement with SITA Information Networking Computing USA Inc. for the CUPPS and related common use systems. The attached proposed Service Agreement will have a four-year term and will be in the amount of \$54,387 per month, the cost of which is reimbursed by the airline users.
- d. AMENDMENT NO. 1 TO PROFESSIONAL SERVICES AGREEMENT, CONWAY CONSULTING, LTD. At the September 8, 2015, Legal, Government and Environmental Affairs Committee meeting, the Committee agreed 2–0 (one absent) to recommend to the Commission approval of the proposed amendment to the professional services agreement with Conway Consulting, Ltd., to continue to provide planning and engineering support services for the Authority in the lump-sum amount, including all expenses, of \$15,200 per month (\$182,400 annually) for a 12-month term. This amount provides the Authority with no less than 80 hours per month (\$190 per hour) of on-airport service.
