5. CONSENT CALENDAR

(Consent Calendar items may be enacted by one motion. There will be no separate discussion on these items unless a Commissioner so requests, in which event the item will be removed from the Consent Calendar and considered in its normal sequence on the agenda.)

- a. MAY 2015 TREASURER'S REPORT No staff report is attached. Included in the agenda packet is the Treasurer's Report for May 2015. This report was presented to the Finance and Administration Committee at its August 17, 2015, meeting at which time the Committee recommended unanimously (3-0) that it be noted and filed by the Commission.
- b. SHORT TERM PARKING SPACE RESERVATION AGREEMENT, CENTURY WEST, LLC, dba CENTURY WEST BMW, LLC A staff report is included in the agenda packet. At the August 17, 2015, Finance and Administration Committee meeting, the Committee voted unanimously (3–0) to recommend to the Commission approval of a proposed Short Term Parking Space Reservation Agreement with Century West, LLC dba Century West BMW, LLC, for 410 spaces in Parking Lot B, located off Hollywood Way. Century West BMW has requested to use parking spaces on a daily basis. Payment for this off-street parking will be in arrears rather than in advance, and this parking is subject to the City of Burbank's transient parking tax.
- c. OTHER TRANSACTION AGREEMENT WITH THE DEPARTMENT OF HOMELAND SECURITY, TRANSPORTATION SECURITY ADMINISTRATION A staff report is included in the agenda packet. At the August 17, 2015, Finance and Administration Committee meeting, the Committee voted unanimously (3–0) to recommend to the Commission that it approve the modified Other Transaction Agreement with the Department of Homeland Security Transportation Security Administration for the purpose of obtaining additional reimbursement for electrical utility charges associated with the use of areas for baggage screening operations at the Airport.
- d. DEPARTMENT OF HOMELAND SECURITY, TRANSPORTATION SECURITY ADMINISTRATION, DIGITAL VIDEO SURVEILLANCE SYSTEM WORKSTATION OTHER TRANSACTION AGREEMENT; DIGITAL VIDEO SURVEILLANCE SYSTEM USE POLICY A staff report is included in the agenda packet. At the August 17, 2015, meeting of the Legal, Government and Environmental Affairs Committee, the Committee voted unanimously (3–0) to recommend to the Commission that the Executive Director be authorized to: (i) execute an Other Transaction Agreement with the Department of Homeland Security–Transportation Security Administration for two new Digital Video Surveillance System workstations in TSA's on-site offices; and (ii) adopt a DVSS Use Policy. The OTA provides for TSA's funding of the workstations and for granting TSA "view-only" surveillance access to specific work

areas under TSA's control. The policy is a requirement of the OTA and memorializes the Authority's existing practice with respect to use of the DVSS.

6. ITEMS FOR COMMISSION DISCUSSION

a. IMG COLLEGE LLC MARKETING AGREEMENT UPDATE – No staff report is included. Damon Dukakis, Associate General Manager with UCLA/Rose Bowl IMG Sports Marketing, will provide a presentation to the Commission; a copy of his presentation is included in the agenda packet. In May 2013, the Airport entered into a three-year marketing agreement, with an option to extend the agreement two additional contract years, with IMG College, LLC, which is the official marketing representative of the Los Angeles campus of the Regents of the University of California and the Rose Bowl Operating Company. The presentation is an update on the Airport's assets as a result of its partnership with IMG College, LLC, which is heading into its third year.

7. ITEMS FOR COMMISSION INFORMATION

- a. AIRLINE SCHEDULE ANALYSIS A staff report is included in the agenda packet. Included in the agenda packet for noting and filing are schedule analyses reflecting changes in service, fleet mix and scheduled operating times for two airlines serving Bob Hope Airport. After incorporating these changes the noise impact area is projected to have a cumulative decrease of 0.06 acres.
- b. JULY 2015 PASSENGER/CARGO STATISTICS AND PARKING INFORMATION No staff report is included. The July passenger count of 334,738 was up 3.8% from last year's 322,512 and the total for the first seven months of the year is up 2.42% at 2,265,450 compared to 2,211,948 through July 2014. Total airline seats in July increased by 2.0%, from 465,356 in 2014 to 474,851 in 2015. Air Cargo volume declined 5.8% to 9.2 million pounds in July 2015, and the year-to-date tally of 62.3 million pounds is down 1.5%. Airline aircraft operations dropped 1.3% the first seven months of the year. A complete report is included in the agenda packet.
