Staff seeks a Committee recommendation to the Commission that it approve an amendment to the professional services agreement with Conway Consulting, Ltd., copy attached, providing for a one-year extension to the term of the agreement. This extension will be for continued planning and engineering support services that Conway Consulting has provided to the Authority over the past year, primarily supporting the replacement terminal project. The proposed amendment to the Agreement provides for a monthly lump-sum fee of \$15,200 per month (\$182,400 annually) that would continue to provide no less than 80 hours per month of on-airport service. This amount includes a 2.7% CPI increase of \$400 per month from the current monthly fee of \$14,800. This monthly fee represents an hourly rate of \$190, an increase from the current \$185 per hour fee.
