a. TEGILE INTELLIFLASH T4200 HYBRID STORAGE ARRAY PURCHASE AND INSTALLATION SERVICES FOR PRIMARY NETWORK. A staff report is included in the agenda packet. At its meeting on October 5, 2020, the Operations and Development Committee voted unanimously (3–0) to recommend that the Commission approve the purchase and installation of two Tegile IntelliFlash T4200 Hybrid Storage Arrays, also known as Storage Area Networks ("SANs"), to replace two current SANs that will soon be reaching their end of life and will no longer be supported by the manufacturer.

The aggregate cost for the acquisition and installation of these SANs is \$123,015.42. Appropriations, in the amount of \$75,000, were included for this project in the adopted FY 2020/2021 budget. The shortfall of \$48,015.42 in appropriations, subject to budget performance in the fiscal year, is to be supported by the carryover of CARES Act funds from FY 2020.

b. ALLIED UNIVERSAL CONTRACT AMENDMENTS. A staff report is included in the agenda packet. Subject to the recommendation of the Operations and Development Committee at its meeting immediately preceding the Commission meeting, Staff seeks Commission approval to the amendments to contracts with Universal Protection Service LP, dba Allied Universal, for airport security/traffic control services and airport consumer item inspection services. The proposed amendments address staffing needs due to the impacts of COVID-19 and extend the term of each contract by one-year. The compensation limit for the extension period will be \$974,413 for the airport security/traffic control services contract and will be \$113,568 for the airport consumer item inspection services contract. The latter service is fully reimbursable by the in-terminal concessionaires.

TEGILE INTELLIFLASH T4200 HYBRID STORAGE ARRAY PURCHASE AND INSTALLATION SERVICES FOR PRIMARY NETWORK

SUMMARY

At its meeting on October 5, 2020, the Operations and Development Committee ("Committee") unanimously voted (3–0) to recommend that the Commission approve the purchase and installation of two Tegile IntelliFlash T4200 Hybrid Storage Arrays, also known as Storage Area Networks ("SANs"), to replace two current SANs that will soon be reaching their end of life and will no longer be supported by the manufacturer.

The aggregate cost for the acquisition and installation of these SANs is \$123,015.42. Appropriations, in the amount of \$75,000, were included for this project in the adopted FY 2020/2021 budget. The shortfall of \$48,015.42 in appropriations, subject to budget performance in the fiscal year, is to be supported by the carryover of CARES Act funds from FY 2020.

BACKGROUND

The SANs, which store the Authority's Primary Domain Network, are nearing its end-of-life cycle. This equipment, originally purchased and installed in December 2015, utilizes older flash drive technology and is strategically located in separate locations at the Airport to support system redundancy. The current equipment provides a total usable storage space of 48 terabytes ("TB") airport-wide that is an integral part of the Primary Virtual Network Servers and End User Data Storage system.

In addition to the equipment reaching its end of life cycle as well as not being supported by the manufacturer later this year, Staff recognized the need to build additional storage capacity for the Airport's current and future operations. The Tegile IntelliFlash T4200 SANs utilize newer technology that provides a smaller footprint, faster data read/write ability, and greater storage capacity. Each SANs provides a total usable storage space of 58 TB for each location with a combined total of 116 TB that will accommodate future data storage needs.

REQUEST FOR BIDS

Staff issued specifications for SANs that utilize newer technology and greater storage capacity using the Tegile IntelliFlash T4200 SANs. Requests for Bids for this specific SAN with installation was issued via PlanetBids. A total of four responses were received on August 26, 2020. Two bid responses were deemed to be complete for the acquisition and installation of the two Tegile IntelliFlash T4200 SANs from the following vendors:

- CHANDLER AUTOMATED SYSTEMS DBA VIGILANT TECHNOLOGIES \$123,015.42
- CLUTCH SOLUTIONS \$162,234.58

Vigilant Technologies has undertaken similar work at the Airport in the past and has completed such work satisfactorily.

BUDGET IMPACT

Appropriations to address the Primary SANs replacement in the amount of \$75,000 are included as part of the Authority's adopted FY 2020/2021 budget.

The cost for replacement is summarized as follows:

Acquisition of two SANs: \$123,015.42
Installation and configuration Included

Total: \$123,015.42

The shortfall of \$48,015.42 in appropriations, subject to budget performance in the fiscal year, is to be supported by the \$1.7 Million in CARES Act funds carried over from FY 2020.

RECOMMENDATION

At its meeting on October 5, 2020, the Committee unanimously voted (3–0) to recommend that the Commission authorize the Executive Director to issue a purchase order to Vigilant Technologies for the acquisition, installation and configuration of two (2) Tegile IntelliFlash T4200 Hybrid SANs in the total amount of \$123,015.42.

STAFF REPORT PRESENTED TO THE BURBANK-GLENDALE-PASADENA AIRPORT AUTHORITY OCTOBER 19, 2020

ALLIED UNIVERSAL CONTRACT AMENDMENTS

SUMMARY

Subject to the recommendation of the Operations and Development Committee ("Committee") at its meeting immediately preceding the Commission meeting, Staff seeks Commission approval of proposed amendments, copies attached, to contracts with Universal Protection Service LP, dba Allied Universal, for airport security/traffic control services and airport consumer item inspection services. The proposed amendments address staffing needs due to the impacts of COVID-19 and extend the term of each contract by one-year. The compensation limit for the extension period will be \$974,413 for the airport security/traffic control services contract and will be \$113,568 for the airport consumer item inspection services contract. The latter service is fully reimbursable by the in-terminal concessionaires.

BACKGROUND

The services covered under these contracts include the following:

- (i) Airport security as defined in the Security Directive issued by the Transportation Security Administration ("TSA") requiring airport sponsors to provide "positive control" and identification of each person needing access to the secured area of the airport. This requires 24/7 staffing of two airfield checkpoints.
- (ii) Traffic control of the airport loop road from the crosswalk at the short-term parking structure to past Terminal B to minimize traffic congestion, improve vehicular flow, manage vehicle activity along the terminal curb front and ensure pedestrian safety.
- (iii) Airport consumer item inspection of any and all commercial merchandise and consumables for sale and/or use by screened individuals within the sterile area of the terminal for any prohibited item as well as allowing entry in this area by approved security identification display area badge holders. This specific service is fully reimbursable by the in-terminal concessionaires, MCS Burbank LLC (food and beverage) and HG Burbank JV (news and gifts).

Allied Universal has been providing these services at the Airport for the past three years and is in good standing in meeting these requirements.

BUDGET IMPACT

Appropriations for these services are included in the adopted FY 2021 budget. Funding for services scheduled to occur in FY 2022 will be requested during subsequent budget year. If, during FY 2021, there is a significant increase in passenger and traffic activity which requires additional staffing hours, Staff will return to the Committee and Commission to seek additional authorization.

RECOMMENDATION

Subject to the recommendation of the Committee at its meeting immediately preceding the Commission meeting, Staff seeks Commission approval of the proposed amendments to the Allied Universal contracts for airport security/traffic control services and airport consumer item inspections services, and authorization for the President to execute the same

AMENDMENT NO. 1 TO PROFESSIONAL SERVICES AGREEMENT

(Burbank-Glendale-Pasadena Airport Authority / Allied Universal)

THIS AMENDMENT NO. 1 ("First Amendment") to the October 15, 2018 Professional Services Agreement ("Agreement") executed by the Burbank-Glendale-Pasadena Airport Authority ("Authority"), a California joint powers agency, and Universal Protection Service, LP d.b.a. Allied Universal Security Services ("Consultant"), a California Limited Partnership, is dated October 19, 2020 for reference purposes.

RECITALS

- A. The parties executed the Agreement to provide for the Authority's retention of Consultant as an independent contractor to provide the following professional services: airport consumer item inspection services.
- B. The parties desire to amend the Agreement to: (i) provide for a one-year extension; and (ii) set the staffing level and compensation limit for the extension period.

NOW, THEREFORE, the parties agree as follows:

- 1. Amendment of Section 1. Paragraph (B) ("Contract Amount") of Section 1 ("Definitions") of the Agreement is amended to read as follows:
- "(F) 'Contract Amount': Four Hundred Thirty-Five Thousand Fifty-Two Dollars and Eighty Cents (\$435,052.80)."
- 2. Amendment of Section 1. Section 1 ("Definitions") of the Agreement is amended by adding a new paragraph (I) to read as follows:
- "(I) 'Supplemental Rate Sheet': the fee schedule set forth in the attached Exhibit E.
- **3.** Amendment of Section 3. Section 3 ("Term") of the Agreement is amended to read as follows:

"3. Term.

- A. This Agreement shall commence on October 16, 2018 and shall remain in full force and effect until October 31, 2021 unless terminated by either party pursuant to paragraph (B) below. The period from October 16, 2018 through October 31, 2020 shall be known as the 'Base Period'. The period from November 1, 2020 to October 31, 2021 shall be known as the 'Extension Period'."
- B. If Consultant breached this Agreement and fails to cure such breach within seven days of written notice from the Contract Administrator, then the Authority may immediately terminate this Agreement for cause. Either party may terminate this Agreement for convenience upon 30 days prior written notice to the other party."

- **4.** Amendment of Section 4. Paragraph (A) of Section 4 ("Compensation") of the Agreement is amended to read as follows:
- "(A) The Authority shall compensate Consultant for performance of the Services, and Consultant agrees to accept as full satisfaction for such work, payment according to the Rate Sheet for the Base Period and according to the Supplemental Rate Sheet for the Extension Period. In no event shall the compensation payable to Consultant under this Agreement exceed the Contract Amount. In no event shall the compensation payable to Consultant for the Services during the Extension Period exceed One Hundred Thirteen Thousand Five Hundred Sixty-Eight Dollars (\$113,568)."
- 5. Addition of Exhibit E. The attached Exhibit E is added to the Agreement.
- 6. Preservation of Agreement. Except as expressly modified by this First Amendment, all of the provisions of the Agreement shall remain unaltered and in full force and effect. In the event of a conflict between the provisions of this First Amendment and the provisions of the Agreement, the provisions of this First Amendment shall control.

AMENDMENT NO. 2 TO PROFESSIONAL SERVICES AGREEMENT

(Burbank-Glendale-Pasadena Airport Authority / Allied Universal)

THIS AMENDMENT NO. 2 ("Second Amendment") to the October 13, 2017 Professional Services Agreement ("Agreement") executed by the Burbank-Glendale-Pasadena Airport Authority ("Authority"), a California joint powers agency, and Universal Protection Service, LP d.b.a. Allied Universal Security Services ("Consultant"), a California Limited Partnership, is dated October 19, 2020 for reference purposes.

RECITALS

- A. The parties executed the Agreement to provide for the Authority's retention of Consultant as an independent contractor to provide the following professional services: airport security and traffic control services.
- B. The parties executed an April 15, 2019 Amendment No. 1 ("First Amendment") to the Agreement to expand the scope of services and increase the contract price.
- C. The parties desire to amend the Agreement to: (i) provide for a one-year extension; and (ii) set the staffing level and compensation limit for the extension period.

NOW, THEREFORE, the parties agree as follows:

- 1. Amendment of Section 1. Paragraph (F) ("Contract Limit") of Section 1 ("Definitions") of the Agreement is amended to read as follows:
- "(F) 'Contract Limit': Four Million Seven Hundred Twenty-Two Thousand Seven Hundred Sixty-Two Dollars and Forty-Four Cents (\$4,722,762.44)."
- 2. Amendment of Section 1. Section 1 ("Definitions") of the Agreement is amended by adding a new paragraph (P) to read as follows:
- "(P) 'Supplemental Rate Sheet': the fee schedule set forth in the attached Exhibit E.
- **3.** Amendment of Section 3. Section 3 ("Term") of the Agreement is amended to read as follows:
- "3. Term. The term of this Agreement shall be as follows: November 1, 2017 October 31, 2018 (Year 1), November 1, 2018 October 31, 2019 (Year 2), November 1, 2019 October 31, 2020 (Year 3), and November 1, 2020 October 31, 2021 (Extension Period)."
- **4.** Amendment of Section 4. Paragraph (A) of Section 4 ("Compensation") of the Agreement is amended to read as follows:
- "(A) The Authority shall compensate Consultant for performance of the Services, and Consultant agrees to accept as full satisfaction for such work, payment according to the Rate

Sheet for Years 1-3 and according to the Supplemental Rate Sheet for the Extension Period. In no event shall the compensation payable to Consultant under this Agreement exceed the Contract Limit. In no event shall the compensation payable to Consultant for the Services set forth in Exhibit "A-1" exceed Two Hundred Twenty Thousand, Five Hundred Dollars and Zero Cents (\$220,500.00) between May 1, 2019 through October 31, 2020. In no event shall the compensation payable to Consultant for the Services during the Extension Period exceed Nine Hundred Seventy-Four Thousand Four Hundred Thirteen Dollars and Forty-Four Cents (\$974,413.44)."

- 5. Addition of Exhibit E. The attached Exhibit E is added to the Agreement.
- 6. Preservation of Agreement. Except as expressly modified by this Second Amendment, all of the provisions of the Agreement (as amended by the First Amendment) shall remain unaltered and in full force and effect. In the event of a conflict between the provisions of this Second Amendment and the provisions of the Agreement (as amended by the First Amendment), the provisions of this Second Amendment shall control.






